May's Meeting



At the May meeting, Al Choy explored a few of the powerful features of *Excel*, which is the most popular spreadsheet in use at this time.

Many new members have not been introduced into using spreadsheets, even through *Apple Works* which is bundled with the iMacs.

The concept of a spreadsheet can easily be understood if one looks at a checkbook register and realizes that each entry is in fact a "cell." These entries are done manually, (think of the many hours some spend balancing the checkbook). All of this activity can be done instantly and accurately – fully automated with *Excel*.

Data entry can be made automatic. For instance, typing Jan or JAN or January in a cell and dragging across or down will fill in Feb, FEB or February. This can be customized so that text, say the number of stores or regions a company has, will be inserted. This is also true of numbers and *Excel* will actually calculate fractions. We need not just make it 1, 2, 3 but it can also be 1.33, 2.57, and it will pick up 3.81, 5.05, etc. Similarly, big columns of large numbers can be added in an instant using the *AutoSum* tool. Numbers can be formatted at will and all entries can be sorted ascending or descending.

Another feature that adds power to *Excel* is the number of functions which broadly encompass financial, date/time, math/trig statistics logical, database, etc. allowing calculation of payments, present values and a large number of business functions; a whole business can be run using *Excel*. Educators can use it for classroom activities from keeping attendance to evaluating the averages of all exams. And on and on.

Apple to postpone Mac OS X:

Apple said that it would release its widely anticipated new operating system software early next year and would use the edition coming out this summer as an additional test version.

Apple had originally planned for the next version of the system, *Mac OS X*, to be the final edition, but the chief executive, Steve Jobs, said the next update would be a public preview beta version and the finished product would be introduced in January.

"It's a matter of still doing at we want and just changing the names," Jobs said in his keynote speech at the Apple Worldwide Developer's conference. Jobs said the change was made in response to developers who wanted more time to work with the new soft-ware. (continued far right column)



Technical Corner

I Ran *DiskWarrior* three times, rebuilt my directories, now *Disk First Aid* runs twice as slow. What can I do?

Back up, erase disk, restore. A great way to speed up the automatic Disk First Aid after a crash and restart is to partition your hard drive. Make a modest size partition for your System Folder and any applications and utilities that must be there and leave room for spooled files and new installs. The balance of your files go in other partitions. The startup DFA run only does the startup partition and will finish in a small fraction of the time used before. Also, a partitioned hard drive will reduce the size and complexity of your volume directories since what was one big structure is now two or more, easily manageable directories. And, as I've said before, any serious directory damage is then limited to only one partition, helping protect your files.

What, if any, are the disadvantages of HFS+?

First, of course, you have to be running Mac OS 8.1 or newer. So you can't cling to ancient software. Most directly related is you have to have Norton Utilities 4.0.3 or newer or TechTool Pro 2.1.1 or newer to work with the Mac OS Extended format. Hopefully, you've tossed the ancient MacTools. Your hard drive, if SCSI and non-Apple, must be updated with a formatter that works with HFS+. Your removables must also be updated if you expect them to back up as many files as your HFS+ hard drive holds in an equal number of megabytes. FWB Hard Disk Toolkit and Intech's HD Speed Tools are the most popular modern packages and support most everything. HFS+ is a bit slower than HFS because of the larger volume bitmap. Also because you can now cram more files onto your hard drive, you stand to loose more if the drive fails, making backup more important. You could find yourself with 25% more stuff to back up now that you have more usable space. Make sure your backup program supports HFS+; you may have to abandon your old free DiskFit and move up to Retrospect. One last potential problem lies in file sharing. Only Macs running OS 8.1 or newer can see the files on a HFS+ volume. So if you do adopt HFS+, you must at least be running 8.1 on all Macs. That excludes the old IIci or any 68030 or lower Mac. I like to

TIP!

Editing PDF-based images with Photoshop 5.x:

Acrobat 4.0 expands the program's built-in (but limited) editing capabilities to include modifying and replacing images contained in PDF documents. A new PDF Format plug-in for Photoshop 5.x is installed with Acrobat 4.0, and provides the link between the two Adobe applications.

The PDF Format plug-in must be properly located within the Photoshop plug-ins folder to be able to access it. If not placed there during installation, move the plug-in into Photo-shop > Plug-ins > File Formats folder/directory. (Restart Photoshop if it was open.)

To allow editing, a PDF file must *not* be protected against changes being made (one of *Acrobat's* security options).

After using Acrobat to open a PDF file that allows changes, select the TouchUp Object Tool from the vertical row of tool icons on the left frame of the PDF. It may be hidden from view initially; it's located behind the TouchUp Text Tool; click and hold the cursor on the Text Tool icon until the (continued far right column)

use *Action Space Doctor* to convert volumes from HFS to HFS+. It's reliable and beats having to backup, erase to *Mac OS Extended* format and restore. All but one 100MB partition on my computer is HFS+. I keep it around for the possibility of running across some old program that doesn't like HFS+. I don't know of any, but you never know.

▶ What are the advantages of HFS+? Mostly, as mentioned, you can store many more small files on large hard drives or partitions thereof. On a HFS volume, the total space is divided into 65,536 pieces. On a 4GB HD, that translates to 128K. Any file is allocated integer number of this increment. The rub is that a small file, like an alias, that is only 563 bytes, takes up 128Kbytes rather than 1Kbyte as it might naturally be. 127K out of 128K is wasted. If you have hundreds of small files, you have a lot of wasted space. You may have, in fact, thousands of files smaller than the allocation block size. You can check a sample files' waste by getting info on it in the Finder. The exact number of bytes is shown in parenthesis along with the allocated size. The smaller number of bytes is called the physical size and the larger number of Kilobytes is called the logical size.

When would you use: a managed hub or switch?

Let me explain the differences between the available choices. A hub is also called a concentrator since all computer and server and network printers connect to it in a star pattern, with the hub in the center. A hub is also called a multiport repeater, since it repeats the network packets entering one port to all other ports. A basic hub is called a *dumb* hub since it has no reporting ability, unlike the far more expensive managed hub which, via the SNMP protocol, can report network utilization and other details. Hubs can be 10Base-T Regular Ethernet or auto-negotiating 10/100 Fast Ethernet. Since you can only have any two network devices talk to each other through a Max of four interconnected hubs, large networks may use stacking hubs where each 12 or 24 port hub interconnect their backplanes to make one large functional hub. Busy networks with more than one device simultaneously talking to other devices (A to B and C to D) will use a switching hub (or just plain Switch) to allow full speed

connections between all simultaneous pairs of ports. A plain hub must divide it's full bandwidth amongst the currently active ports. If too many simultaneous connections exceed the full bandwidth, you get collisions of network packets causing the packets to be re-sent and slowing down the network. For a network of many users with File Sharing on, and many people printing to a variety of printers, a Switching hub is a must. The price for a Switch used to be much higher than a plain hub, but the price has come down, as has support for Fast Ethernet. Only large companies with a network administrator to keep a complex and busy network going smoothly usually buy the fancy managed hubs. With special software with charting and packet analysis, a network analyst can determine when one user or server requires extra bandwidth and specialized hardware. One nice thing about a managed hub is it's ability to alert the administrator of a port that has been shut down due to excessive traffic – a rare fault usually caused by a defective network interface card or a really screwed-up computer. There are Mixed Speed hubs. The most popular regular hub will have all ports rated the same, but a mixed hub might have something like eight regular 10Base-T ports and one or two Fast Ethernet 100Base-TX ports. There are some Extra Fast Gigabit Ethernet hubs with one or more gigabit ports. New Macs have 100Base-TX capable Fast Ethernet ports, but Gigabit Ethernet speeds can be added with a PCI card. The extra speed is usually reserved for busy high-performance file servers.

I'm concerned about the *ILoveYou* virus. What can I do about it?

First, you can relax, since that Trojan Horse, or Worm effects *Windows* PCs, not Macs. The best (and free) prevention is to configure your e-mail software to only download the first, say 4K, of an e-mail, thus preventing the reception of any attachments until you can review the e-mail body. Anything suspicious can be deleted before you ever see the attachment on your machine. Then you can mark any desired attachments and re-get new mail to download the attachments you do want. AOL doesn't support this, but *Netscape Communicator* and *Outlook Express* do.

Object Tool's icon is visible, then select it to make it active.

Position the TouchUp Object Tool's icon on the image you wish to edit; click once to select the image, then drag it from the PDF file, or better yet, while holding down the Option key, doubleclick on the image in a PDF to automatically launch Photoshop, directly opening the selected image for editing.

After making the desired changes in Photoshop, simply save the image to have those changes applied to the version of the image in the PDF. Or use Save As to save a copy of the selected image as a separate image file, choosing from the list of Photoshop supported file formats - including saving the image as its own PDF file.

Photoshop 5 and above can also be used to directly open entire (unprotected) PDF pages. However, v 5.0 may not open some PDFs created with Acrobat 4.0, which uses the v.1.3 PDF technical specification.

Photoshop can also be set to open a batch of PDF pages into a folder or directory, then used to automatically create contact sheet pages of thumbnail images from the PDF pages.
