How to Buy a Digital Camera by Charles Maurer TidBITS (Continued from the May Forum)

In these situations, the overall quality of the picture is rarely optimal so the loss of resolution will never be noticed. On the SD-10, medium resolution still records as much information as

can be reproduced on a full page of a glossy magazine. Dust is the *bete noire* of image sensors. In almost every camera with interchangeable lenses, dust wafts into the camera whenever you remove a lens, then it lands on the sensor and creates innumerable specks in an enlargement. Preventing dust from entering the camera saves a lot of time cleaning up pictures. The SD-10 covers the opening behind the lens with a sheet of transparent plastic. Some

dust manages to get on the sensor anyway but much less than the norm.

For studio photography, it is useful to be able to plug the camera into a laptop computer and see your pictures immediately at a reasonable size. The SD-10 can connect by USB or FireWire. When connected by FireWire, pictures show up in Sigma's PhotoPro application in seconds. To light the poster linked below, I used four strobes and three halogen lamps. I found it

quicker and easier to balance them and find the exposure by viewing the image than by using a meter

Digital cameras incur hidden costs for memory cards. Price them early in your shopping. In this respect the SD-10 has a significant advantage over its competition: it stores raw images from its Foveon sensor in only one-half the space required by an equivalent Bayer sensor. Also, writing a picture to memory can

at *amazon.com*. Most software nowadays does not come with printed manuals. They cost too much to print, take up too much space and weigh too much. Most people won't read a fat book anyway, so there are tutorial CDs like those from *VTC.com* and *lynda.com* and *macacademy.com*. Only *MacAcademy* has anything, two volumes, in fact, specifically on *PowerPoint 2004*. \$39.95 each.

▶ I'm now running *Mac OS 10.2.x.* I have *Panther*, still in the box and *Tiger*, also still in the box. Should I wait for things to settle down with *10.4* updates and do I have to install *Panther* first? Have you heard anything bad?

Well, at least you're consistant. I assume you have a machine with built-in FireWire, so you can in fact install *Tiger*. First off, you don't have to install Panther first to install Tiger. One one hand, if you do install Panther first, you can install some updates that need a minimum of Mac OS 10.3 and then see how that goes and then update again to 10.4.1 and a few more updates for that. On the other hand, if you have to update almost everything (as you probably do if you haven't updated the Mac OS since before October 2003 when *Panther* shipped), then maybe a one-big-leap would be less disruptive. Kind of like ripping off a bandage quickly to get it over with, rather than trying to peel it off slowly and causing more pain. First

good on screen but terrible when printed. You've made a "Beauty and the Beast." The fix? Check out what it looks like on screen at 200% magnification. If graphics are jaggy, replace them with larger versions. 5. When searching through your PDF, Reader can't find anything, not even the word "and?" You've not created a monster, but instead a "Searching for Bobby Fischer" PDF, which probably means you're creating "Image Only" files in Acrobat. 6. The number-one trouble spot in PDF usage? Fonts. People who don't choose to embed fonts create "Zombie" PDFs, which can closely resemble the original--if Acrobat chooses substitute fonts well.

take a while and some cards are faster than others. Lexar make some of the faster cards and use some proprietary technology they call write-acceleration. The SD-10 supports Lexar's write-acceleration technology.

Another hidden cost with digital cameras is spare batteries, especially if the batteries are proprietary. I planned to use my camera far from electricity in the Himalaya, so it had to run on disposable batteries. The SD-10 uses AA or

CR-V3 batteries but it turned out that they need to be lithium cells. Despite what the manual says, other kinds don't work, Also, I have found the SD-10's battery life to be disconcertingly short, especially in cool temperatures.

Long before the batteries die, they act dead then come to life for a few pictures after the battery tray is removed and replaced, and they will continue do this a number of times. It looks to me as though the camera's tolerance

for both internal resistance and voltage drop are unrealistically demanding. A second pair of batteries in parallel seemed called for and can be had by buying an accessory grip/power-pack (\$130) that screws onto the base. I bought one immediately upon my return from India. It adds a bit of weight and size, but in compensation. it makes the camera more comfortable to use. On the other hand, it leaves the camera wobbly

For snapshots, a built-in flash is useful. Outdoors, it is often convenient to have a builtin flash to fill in shadows. I wanted one for the latter purpose especially, but the SD-10 does not have one, so I bought a Sigma on-camera unit purportedly designed for the SD-10. This flash zooms (with a scale for a 35mm cameras), bounces in all directions, and adjusts its exposure automatically. (Continued in the July Forum)



### Networking 101:

Q: What is the difference between a hub and a router? A: A hub connects devices on the same network, while a router connects two networks together. For example, an Ethernet or AirPort hub (i.e., a Base Station) connects Macs on your home network. A router, on the other hand. connects your home network to your ISP's network, and therefore to the Internet. Some devices (like the AirPort Base Station) are both routers and hubs. -MacAddict Magazine

### Letter Small vs. **US Letter In the Page Setup dialog:**

Sometimes you'll see a Letter(Small) choice as well as a US Letter choice. The difference is that the US Letter choice allows the application to print to the limit of the printer's imageable area, while the Letter (Small) choice always leaves a half-inch margin around the edge of the paper. -MacAddict Magazine via Design Tools Monthly

thing I'd suggest is going to www.versiontracker. com/macosx/and searching for the latest version of everything you can find. Some of the things you may find there are free updaters and some will require money to purchase more substantial upgrades. Please note that there are some updaters that will work in *Panther* and *Tiger*, and some that are *Tiger*-only. Look for the obvious in your *Applications* folder, and don't overlook plug-ins for other applications. Also look in the *Utilities* sub-folder. Some programs do work in Tiger, but may need to be re-installed. Windows Media Player 9 and Stuffit Deluxe 9 seemed to need to be reinstalled. Norton Utilities won't work under Tiger, nor should you boot from the CD and attempt to repair a *Tiger* hard drive. Look for a replacement like DriveGenius. DiskWarrior 3.0.3 can be used. The updated TechTool Pro 4.0.4, which Micromat says is *Tiger*-compatible, may cause more trouble than it repairs. Norton AntiVirus for Mac 9.0.3 is partially compatible, but version 10 is fully. You might also try switching to Intego's VirusBarrier X 10.1.5. Look in your System Preferences for Login Items. It's a fest to make a paper list or a screen shot to record what's here and remove anything not already *Tiger*-ready. Then perhaps a check of drivers for scanners, printers, card readers, battery backups, external firewire drives, and PCI cards (which often are SCSI cards or extra FireWire, USB or Ethernet ports) and even screen savers. These live in various parts of your *Library* folder(s). It seems many Lexmark and Samsung printers will be a problem. Microtek seems to not have Tiger-ready drivers for their scanners, but Canon and Epson do. Canon and Epson seem to be *Tiger*-ready with their printer drivers too. Apple has included many, many drivers on the *Tiger* install DVD. See *http://docs.info*. apple.com/article.html?artnum=301175 for a table of all included printer drivers. HP has released updated versions of their drivers or updaters for Tiger users. There are patchers for many common Brother printers as well. You may have to delete and re-add printers in the Tiger Printer Setup Utility. The all-in-one OfficeJet series would be limited to printing at this time. If there is a question and you're waiting for the manufacturer to respond to your inquiry, check out the reports on www.macfixit.

com/and www.macintouch.com/. It's best to disconnect *FireWire* drives before updating. If you are running off a *FireWire* drive, then make sure you have the latest firmware for the bridge chip inside, often a Oxford 911 or 922 chip. Popular LaCie drives should be updated with the LaCie Update Tool v1.3.2 at www.lacie. com/download/drivers/LaCieUpdateTool.dmg You should check for damaged directories with DiskWarrior or TechTool or Norton Disk Doctor before updating as well as repairing *Permissions* with Disk Utility. Repair them again after the 10.4 upgrade and the 10.4.1 update (and DVD) *Player 4.6* etc. updaters) is run. There have been many reports about problems upgrading from older versions of Apple's Mail. I found this Web page worth bookmarking for this issue: www. robservatory.com/archives/2005/05/20/hownot-to-upgrade-to-mail-in-104/. Anyway, most people found *Panther* (10.3) to be much faster than *Jaguar* (10.2) and on G4s, *Tiger* is a bit faster than Panther, but Power Mac G5's can be far faster than *Panther*, so a upgrade from 10.2 to 10.4 is sure to be much faster. Overall speed aside, I've not been happy with Spotlight and preferred *Finding* with *Panther*. I can also say I have not been impressed with the *Dashboard*, so it's quite possible you may be better off with Panther and leave the Tiger in it's cage. I'm sure in time there will be more compelling reasons to install *Mac OS 10.4* and of course very new Macs have no choice, so living with *Tiger* may be unavoidable.

(Sore Eyes continued from Page 4.) folder called *Epson Printer Drivers 2*. There you will (according to Apple Care) find the desired driver. How were we supposed to know? Does this work? Who knows? Tune in tomorrow for the continuing saga of "Upgrading and Why Do We Do It?"

The above sounded hopeful as well as weird. In reality, when we got back to New York, and changed the way we handled our NY printer (Epson 870), making it a *Rondezvous* printer as well, the computer seemed to suddenly find the 740i as well. At any rate it made for interesting speculation. Now both printers work as desired. Is it possible that the techs make up things on the spot, when they can't answer a question?

#### **Full-Screen** QuickTime:

### **Best Scan Resolution for Line**

When scanning line art (such as a logo or signature). try to create a file containing 900 ppi, at the size you'll be printing it. The human eye can't distinguish differences in image quality past 900 ppi, and lower ppi may show jagged edges when printed on an imagesetter.

(For laser printed output, 600 ppi should be fine.) -Design Tools Monthly

### **Sore Eyes**

Since many of our readers keep track of all our computer complaints, it seems a good time to update our story. We replaced our iBook G3 with a new PowerBook G4 with loads of memory and greater speed. We had to upgrade the *Airport* to *Airport Extreme* when our router died as well, but the *Airport Extreme* gives us great power and enabled us to modify and use the correct MTU so that upgraded sites come in completely. Now we have a new discovery that is really weird. All we planned to do when we traveled upstate was to reinstall the old printer (Epson740i) driver, at least five years old.
