#### **TidBITS Troubleshooting Primer, Part 1**

For instance, take the example of a wireless network that also has one computer connected via an Ethernet cable. In this sample network, the one wired computer is used as an informal file server. You're using one of the wireless computers, and you suddenly can't connect to a shared folder that's worked fine before. What

- are the pieces of this system? Let's determine what must be true for the situation to work properly, after which we can analyze each of the components.
- ► On your computer, you need properly installed file sharing client software.
- ➤ Your computer must have a working connection to the wireless access point.
- ► The access point must allow you to see a computer connected via wired *Ethernet*.
- ► The wired *Ethernet* computer must have a working connection to the access point.
- ► File sharing server software must be running on the wired *Ethernet* computer.
- A folder must explicitly be shared on the wired Ethernet computer.

You could certainly break these pieces into even smaller pieces, but this should be sufficient to get started.

Keep in mind that what I've just described

is only one working system, which is important, because if there are other working systems – other wireless computers that can see the file server – that can help you zoom in on the problem quickly.

Make sure to check off each question you answer in your notebook, and note any interesting things that happen when you perform the test. I don't suggest you do this because you're going to forget what you've done while you're

# Lighten and darken portions of an image in *Photoshop*:

Enhancing the colors in an image can be a relatively simple process. Don't believe us? Try it for yourself; open an RGB image to work on. Then, create a new layer in the *Layers* palette. Now, choose *Edit* > *Fill.* In the resulting Fill dialog box, choose *50% Gray* from the Use pop-up menu and click *OK*.

Now, in the Layers palette, change the blending mode of the layer to Color Burn to darken the image so that it's oversaturated. Also, lower the Opacity of the layer to 70%. Next, select the Brush tool (Paintbrush tool in version 6.x) with a soft, round tip. Then, on the Tool Options bar, set the brush's Opacity to 20%. Also, make sure the foreground color is set to white. Now, paint over the areas you want to lighten. It's color correction made easy! -Element K Journals

### **Bradley's Tech Session**

### ▶ I have a new Power Mac G5 on order. How can I move my files from my old Mac to it?

If it's a Power Mac G4, eMac, PowerBook G4, PowerBook G4 (FireWire) or a iMac or iBook with *FireWire*, you can use a 6-pin to 6-pin FireWire cable and put the old Mac into FireWire target disk mode and drag your files right over. You can't hook up the old parallel ATA hard drive into the G5. If the old Mac is a Blue and White G3, the best way is to connect an external *FireWire* hard drive, copy your files to that and then connect the drive to the G5. If it's still running Mac OS 8.6, get the FireWire 2.3.3 update online at Apple's Knowledgebase article #86020. If you have a second monitor and an older Mac with a Ethernet port, you can wire the two directly together and turn on File Sharing on the old Mac and Connect to Server on the G5. If the old Mac is running older than Mac OS 9, then AppleTalk will need to be active on the G5. This should work fine all the way back to the Centris/Quadra generation which may need a Thin Ethernet AAUI transceiver. They did not have the built-in RJ-45 connection. Alternatives include burning a set of CD-R or CD-RW discs of your old data or copying your files onto a set of jaz disks if you have these mechanisms. The jaz disk drive uses a high density 50-pin narrow SCSI-2 connection and the G5 does not have a SCSI port on-board. The new G5 requires a PCI card that works on 3.3 volts, unlike the older 5v, so it's likely that a older SCSI card will not fit and not work. You could use an Adaptec 29160N card, but ahh... just to warn you – it's \$299. Don't bother transferring Virtual PC and it's large drive file. It won't work on the G5. If Microsoft, who bought *Virtual PC* from Connectix, ever upgrades the Mac version to release 7, then it should work on the G5. The G4 processor had a special instruction that lent itself to Intel processor emulation. Microsoft will either have to rewrite the program from scratch or write a patch for the missing CPU code. VPC 6.1 took advantage of multiple processors and was quite responsive on a fast G4 with Quartz Extreme. Never took advantage of a good video card, emulating a slow old card. It's my opinion that Microsoft has little to

gain in advancing the Mac version of Virtual PC, they were only interested in the Windows version. They will probably let the product sit for months before claiming it is not in their business interests of making money to invest the manpower to take *Virtual PC* to the next level. As Apple transitions to the G5 processor, the available market for VPC 6.1 will shrink, so they probably will discontinue that as well. They have little to lose, as a Mac user who also wants to run Windows software, can go out, buy a WinTel machine from the likes of Dell, with a licensed copy of Windows pre-installed, and run things faster than an emulation. They don't care that it will take more space and more money.

▶ Do you recommend an anti-viral program? I hear about so many virus and Trojan horse warnings for *Windows* and none for the Mac.

It's true there are very few Mac infections, but some idiot released on the Web a potential vulnerability and how to exploit it. Many businesses worry about passing on a Windows virus, even if their Macs are unaffected. For this reason, it's wise to buy Norton AntiVirus or the bundle with Norton Utilities called Norton SystemWorks. The competition Virex does not detect Windows-type viruses. You can also get a measure of peace of mind when your Mac starts acting up, and you're thinking, maybe I do have a virus, you can scan and repair to be sure. Mac OS 10 does not have any built-in anti-virus software. Some people thought the UNIX underpinnings of Mac OS X would allow more virus infections,

troubleshooting, but because you may have forgotten by the next time the problem happens. Plus, if you end up wanting to ask someone else for help, you can say authoritatively that you had indeed tried some test with negative results.

In most situations, the solution to your problem will make itself clear during this process of answering questions. Perhaps it's summer, and the reinstallation of your screen door is blocking the Wi-Fi signal, or perhaps

your spouse configured the computer in an unusual way for your nephew's game. Maybe your access point lost track of the wireless-to-wired Ethernet bridge settings, or maybe your computer or the access point just needed to be restarted.

**Get Expert Help** With truly tricky problems, your tests won't reveal any conclusive answers. Don't feel too bad, because if you've followed the procedure so far carefully, your failing is

most likely that you don't understand all the parts of the system well enough. What to do next? Ask for help, of course, and that's where I'll look in the next part of this article.

#### **TidBITS Troubleshooting Primer, Part 2**

In the first installment of this article, I talked about the basics steps necessary to troubleshoot any problem, including describing the problem, breaking the system apart, asking yourself questions about each part of the system, and finding answers to those questions and tests.

But what if, after all that, you still haven't been able to solve the problem? Failure to solve a problem on your own is no cause for surrender, because you usually just don't understand the system well enough to break it into appropriate chunks.

#### Blinding Finder

One of the most glaring differences between OS 9 and OS X is the way folders are opened.

In OS 9, doubleclicking a folder opens a new window that displays the contents of that folder.

In OS X, doubleclicking a folder displays the contents of that folder within the same window, eliminating the previous contents. This can take some adjustment.

There are several work-arounds, however. You can hold down the *Command* key when double-clicking a folder to force a new window to open.

Those of you who genuinely prefer OS 9's folder behavior can make a more permanent change: Select Preferences from the Finder menu, check the option to Always open folders in a new window, and close the window. Things will now be normal.

#### Open Files in Trash Can:

If you moved some files to *Trash* and you are still not sure

but unlike LINUX, *Mac OS X* is based on the BSD extensions, which along with *OS X* itself, has been proven to be the most immune from infection. Still, I use it and have downloaded infected files from newsgroups. One little "gotcha" with *Norton Utilities* at the moment: It can't be used to start up the new G5s, as they require *Mac OS 10.2.7*, and the CD has an older version. You can have a second hard drive, either internal SATA or external *FireWire* with a *Carbon Copy Cloner*-copied *System* on it, along with *Norton Utilities*, to repair your startup drive.

▶ I've heard if you have a very fast cable modem connection or an office with a T1 connection, it's better to turn off your Web browser's cache. How do you do this?

If you are using Microsoft's Internet Explorer, it's found in the Advanced section under the Web Browser portion of the Preferences. Just change the Size: to 0 MB and then click the Empty Now button. For Netscape 7 or Mozilla, look in the Advanced Category of Preferences

and click on the *Cache* sub-category. Change the Cache to 0 MB, click the Clear Cache button, click OK to save the change, then quit and start *Netscape* again to make the change take effect. AOL for Mac OS X: before signing on, in Preferences, click on the WWW icon (category) and use the Cache Maximum Size: pop-up and change to *No Cache* and the click the *Empty Cache Now* button and then the *OK* button. Apple's Safari itself does not allow you to change the cache settings. Get the freeware Safari Enhancer at www.lordofthecows.com/ *safari\_enhancer.php.* When you run it, in the first tab, Lasting Options, check the option to Deactivate Cache. I've tried the Use custom link colours option myself, but the change did not last long.

I want to share my cable modem with another Mac on another floor of the house, beyond the range of Airport wireless net. Get a normal wired cable router with a four port switch. Asante's FR1004 is a good choice for speed issues. You can get a Linksys BEFSR41 router for less and requires zero configuration. Then get a pair of Neverwire 14 units from Phonex Broadband. The twin pack is called the QX-202. See www.phonex.com/prd\_nwl4.htm for details. The pair basically uses the house power wiring as a *Ethernet* wire. There is no configuration for the powerline bridges except you slide a switch on one of the units (to hub) for the connection to the router and leave the other one set for PC for the connection to the Mac's Ethernet port.

(Sore Eyes continued from Page 4) into the OSX version using the new fancy printer to get the envelopes as desired. The folks who write instructions, have far to go. It is like the early days when we used to go to dBase meetings. Every time we had a problem, the dBase representative would say. "That's an anomaly, not an error in dBase. Here's a workaround that will help you." They kept this line going for several years, until rBase and FoxBase were developed without so many errors.

The message is clear, at least in my own mind: Hang on to some old versions, as long as you have hardware to run them. This technique keeps you going if the chips are down.

if it is OK to delete them (especially if they have explicit names like "untitledx. txt", "toto.tif", etc.), it is possible to open them without moving them out of the trash. Remember that double-clicking a file in the *Trash* won't open it.

However, by Control-Clicking on the file and selecting the Open with contextual menu item, the file will open in the selected application, Now you can review your file before deleting it without having to move it to the desktop first. -AppleGram, Apple Corps of Dallas TX

### Force Quit from Dock:

### **Sore Eyes**

You must start out with the awareness that I'm a computer applications teacher (retired). I've spent the last 15 years teaching people of varying ages and abilities, from Junior High levels, through High School, College and adults. I generally teach word processing, spread sheets, data bases, and even (hush hush) Windows. I've used Word Perfect, my personal favorite, Word, Claris, and assorted other programs that seem to have disappeared from the world. I've used the earliest versions of spreadsheets, all the way up to Excel (and even dBase), FoxPro, Access (my favorite hate) along with others that I can no longer recall. I list these credentials not to brag, but to indicate my own downfall.

We're sending out invitations and I needed to use a mail merge. Using *OS X* and *Excel*, I created a spreadsheet listing to use for my data. The invitation was written in *Word*, and I even managed, after several rewrites, to include the time and place of the event. Then came the crisis.

Without research, I was unable to print the envelopes. Turning to the *Help* function, which might as well have been written in Greek, had no effect. The *Help* function was no help. Referring to the piles of books standing untouched on the shelves was interesting but not productive.

Success at last! Only because we still have an older version of *Word*, ('87-'88) that runs on *OS 8.6 – OS 9.0*. Although the technique is virtually the same as in *Word for OS X*, the *Help* instructions seem much clearer. In addition, the printer settings on the older printer were simpler to use. Once I was able to use the mail merge instructions in the old version, we went back and interpolated our discoveries, (Sore Eyes continues on Page 3)
