## **April's Meeting**


Acrobat 4.0, which has just started shipping, was the featured presentation at our April meeting. Mark Middleton of Adobe Systems, started of by giving us an overview of Adobe's products and corporate strategy. An interesting point: 80% of the images that appear on the World Wide Web have undergone some sort of editing in Photoshop.

Acrobat 4.0 includes support for ICC profiles, Postscript Level 3, TrueType fonts, etc. A new tool bar on the left side makes it easy to review documents and recommend changes by making handwritten marks, add text annotations, use sticky notes, etc. Mark demonstrated a few of these features. A major upgrade, this software has a great number of features to be covered; we will be doing a review of this product using our members' files and showing how the PDF format is used in the preparation and distribution of this newsletter.

Mark concluded the meeting with a brief

overview of InDesign, expected to ship in July. This looks like an exciting product and we also expect to do a formal presentation and review this product in the fall. Adobe contributed a number of raffle prizes for this meeting. Our thanks to Mark and Adobe Systems for their continued

## **More May Mumblings**

### Learn about Clipping Files

Dragging a selection of text, pictures, sounds, or movies to the *Desktop* or any *Finder* window creates a clipping file. Although there are these different types of clipping files, the primary use of clippings is for text. These clipping files can be used for storing and manipulating sections of text. These sections of text can be easily added to most documents by just dragging them where you want them to be inserted.



To create a clipping file you can simply make a selection in most applications and drag that selection to any *Finder* window. If the application you are using doesn't support the creation of clipping files, usually your attempted drag will result in a new selection. Most Web browsers don't support the creation of clipping files so if you are trying this out for the first time in your Web browser, don't be discouraged. The three best places to start with creating clipping files are with

applications that ship with every Mac. *SimpleText*, *Stickies*, and *Scrapbook* all support the dragging of selections out as clipping files.

Classically, clipping files have been used for quick access to frequently used sections of text such as an address, phone number, or any other text that you use on a regular basis. Creating a folder to hold these clippings can provide easy access to your most frequently used sections of text. The other primary use for clipping files is to

From Scott Randell: Syquest has been bought by lomega and there is information still available on their Web site (www.syquest.com)

They are selling off inventory and, as you will read in their announcement below, lomega hasn't decided what is going to happen with their company.

"Thank you for your inquiry. Here is the situation: SyQuest entered into Chapter 11 on November 17, 1998, at which time manufacturing ceased. We are selling from our inventory of completed units.

lomega made an offer for a large portion of SyQuest, which was accepted by the court on February 24. The deal is in the final closing stage. lomega has not stated their intention for resuming manufacturing and sales for SyQuest products.

## **Recently Encountered**

Enough is enough. As the market matures and profit margins shrink, some software companies are counting on their upgrades to carry them through. Software companies need to make a profit from upgrades, but some of these companies are abusing the privilege, producing must-have *latest* versions which are usually quite expensive and offer no more than a cosmetic overhaul and an additional button on a floating toolbar.

If these companies are going to charge for updated versions of their software, they should at least ensure that the new version offers positive benefits to the end user. An upgrade should be more than just a simple bug fix, it should also install easily, be more stable, and improve compatibility with other applications, all without making the output from earlier versions incompatible or harder to use. An upgrade that doesn't do all these things makes one wonder if we shouldn't just wait for the next *complete* release.

*Teach! Lite, Teach! Pro* and *Multi-user* make a fully fledged multimedia authoring package containing more facilities than many commercial programs. Use it to create multimedia presentations, slide shows and talking books.

More than 70 improvements have been made to the *Teach!* software suite, including: vastly improved support for *QuickTime®* 3, with support for movie controllers, interactive wired sprite animations, animated GIF's and QTVR; improved keyboard control of interactive quizzes; a project archival facility; transmission of projects over the Internet made easy; generation of standalone applications now possible; just one mouse click is required to change a project into an independent double-clickable application; multi-lingual projects now included with *Teach! Lite, Teach! Pro* and *Multi-user 1.2.*

## **Technical Corner**

• I have to replace my CD-ROM drive in my PowerComputing Power Wave 120. Do you have any recommendations about internal vs. external, and what manufacturer's item to buy?

I'd go internal to save money, keep the SCSI chain as short as possible, save a power outlet and desk space. I like the Toshiba models. I have a 32X model. You can get a fast 40X Toshiba SM6401 internal for \$100. If you use a lot of clip art CDs, consider a Nakamichi internal 16X five-disc mini-changer for \$190. As an alternative, consider replacing the old drive with a CD recorder. The preferred Yamaha CRW4416S 4X Record or ReWrite and 16X player goes for \$319, but you can get a Panasonic 4X record, no rewrite and 8X player for \$259. The usual mail order houses like MacZone and MacMall mostly have externals, so go for places like MegaHaus or ProDirect. I saw an ad at MicroCenter for a CD drive bundled with FWB's CD-ROM and Hard Disk Toolkits, but it didn't say what mechanism was used. How do you find out? Ask them to dig it up, research their information. Maybe they will open a box, and examine the mechanism for manufacturer's labels. If they can't, and just call it a generic model, I wouldn't buy it. Even if it was bundled together with the software and you'd assume it would at least work together, I wouldn't go for it. It could be a piece of junk that's flimsy and doesn't quite work right.

• I upgraded from *Illustrator 5.5* to 7 recently and when opening some files I get a dialog box asking me for the linked EPS file. I can replace it, ignore or cancel the file open. Is this a problem with 7.0? *Photoshop* opens the file, but it's it's not usable or editable there.

The problem is for those *Illustrator 5.5* files where you placed or embedded another EPS file, like a logo. *Illustrator* didn't actually copy the linked file's contents into the current file, the one you are now trying to open in *7.0*. It just imported the EPS Preview image and a reference to where on your hard drive the linked logo file is. When *Illustrator 7* tried to open the file, it examines the file and finds the reference to the linked logo EPS file. It then pauses and tries to open that file. If it can't find

Some of us like the old ways and consequently want to run Mac OS 8.5x with that old familiar gray screen.You can still find it in a Scrapbook file (item 91) inside the Mac OS 8.5x CD Extras folder called Additional Desktop Patterns. You can then paste this item into your Appearance Control Panel. -Ted Landau

act as a way to handle multiple sections of text at one time. If you have a large document that you need to reorganize large sections of text you can drag each section of text out as text clippings and drag them into a new document in whatever order you would like.

Mac OS 8.5 provides all the usefulness in clipping files that has existed since System 7.5 and adds a new functionality that makes handling Internet URLs (Uniform Resource Locators) much

easier. Mac OS 8.5 automatically examines the content of the text that is dragged from your applications for certain types of Internet Locations. The most common types are Web site URLs and e-mail addresses, but most URLs are supported including http, ftp, file, e-mail, nntp, afp and AppleTalk. These special Internet clipping files (called an Internet location document in a Mac OS 8.5 technical note) still function as standard clipping files. When dragged to a supporting

application, they will deposit the text they contain at the drop point just like any other clipping file. The special functionality added in Mac OS 8.5 allows these clipping files to be double-clicked and pass that URL to the appropriate application for loading over the Internet. Double-clicking a clipping file containing an e-mail address will open a new e-mail addressed to that address. Double-clicking a clipping file that contains the URL for a Web page will open your Web browser

and load that Web page over the - B.C. (D) Internet. You can even drag a B server from the Network browser out as a clipping file that can be double-clicked to open a window in the Network browser with all the Volumes available from that server.



America Online has added a new e-mail attachment warning to AOL 4.0 (possibly in response to the Melissa virus scare). Beware: making the wrong set of selections here can trigger a bug that causes a freeze or crash.

When you get an e-mail with an attachment, AOL will now put up a warning message asking whether you want to proceed with the download or not. At some point, there will also be a checkbox to disable getting this same warning in the future. If you select to download the file and enable the Don't show this warning again check box, you will likely get a freeze or unexpected quit soon thereafter. Rebooting will not fix the problem.

To correct the problem, you must remove the DOD Database from within the Online Files folder and when you next open up AOL, it will create a new DOD Database, thereby correcting the problem - or just re-install AOL.

the file by that name in that location, you'll get a message like you've got asking you to find the linked file for Illustrator. It's asking you for a replacement target file for the link. If you've deleted the linked EPS file, your document is screwed and you must hit Ignore to delete the link. When you open the file without it's linked file(s) in *Photoshop*, *Photoshop* can rasterize the Postscript illustration, but can only use the 72 dpi preview of the lost linked file. There was an update from 7.0 to 7.0.1 which did not address this exact problem, but related ones. Of course, now there is 8.0. My guess is you moved or deleted your linked files, not realizing you still needed them and it's not Illustrator 7.0 at fault. Use Markzware's FlightCheck to scan your EPS files for missing linked files to get an overview of the extent of the problem among your files.

### Selective Blurring & Sharpening in Photoshop:

In Photoshop, you can selectively blur areas while sharpening others. Make two duplicate layers of your image. Sharpen one and Blur the other. Use the Eraser and Lasso tools to remove the parts of each layer that don't need that layer's effect. Finally, adjust each laver's opacity and flatten them.

Return the switch box and get a Momentum Printer Ready Port Doubler and switch to a pair of PhoneNet connectors for the HP. You'll have to switch AppleTalk active for the HP before selecting Laser Writer 8 in the Chooser and inactive for the SC800, but the Port Doubler will switch the connections. Plug the SC800 into Port A, and the PhoneNet to the 6MP in port B. To avoid the AppleTalk switching, you can get a *LocalTalk* card (\$129) for inside the the SC800 and a third PhoneNet connector so that both printers are on LocalTalk and then you won't need the Port Doubler. You would then use the SC 800 (AT) driver. As an alternate, if your *Ethernet* port is free (if you have one) or you are already on a Ethernet network, get a Farallon iPrint LT and connect the 6MP with PhoneNet to your Mac through the *Ethernet* port/network hub, leaving your printer port free for the SC800. Set your AppleTalk to Ethernet and leave it on even

when selecting the SC 800 in the *Chooser*. That works better than the PortDoubler option because you don't need any new software to make it work.

▶ I installed *QuickTime* (I don't know what version) on my G3 and now at start up I get a message that my installation of *QuickTime* failed because it was already installed. I

### found it in my System Folder and in my Extensions folder.

**More Technical Corner** 

I would assume that the stuff loose in the System Folder should be tossed since the elements all go in the Extensions folder. You should toss everything labelled QuickTime in the System Folder, including the Preferences and the Settings Control Panel and reinstall. Otherwise, wherever there exists a duplication in name, compare the versions, and toss the older one making sure the newer ends up in the Extensions folder. This method may result in a mismatch of *QuickTime* components, so it's better to follow the first procedure of tossing everything first and reinstalling. The G3s first came with OT2.5, but 3.0.2 is the latest. You may want to download that first and install the 3.0.2 version. When you're all set, make sure you turn off the CD Autoplay option in the **QuickTime Settings** Control Panel to make sure you don't get an autostart virus.

• Every time we start up a Mac at work we get a prompt to insert the Gold Forest disk, which is a Zip we haven't used in a long time. Zapping the PRAM and rebuilding the *Desktop* didn't help. Starting up with *Extensions* off, the problem goes away, but we don't have the time to turn off half the Extensions, etc., in order to isolate the problem. We use Suitcase.

You must have opened a font located on the Zip in *Suitcase*, and that font is part of your Open at Startup set. Since you don't allow Suitcase to open the font, if you open Suitcase and examine the Open at Startup set's members, the only font not actually open is the missing font from the Zip. Delete the entry in Suitcase. If you really do need this font, insert the Gold Forest Zip, copy the font and any related Postscript font files to your hard drive. Eject the Zip and add the new font to the Startup set in Suitcase.


### ▶ I have a Power Mac G3/300. Occasionally, I get a flashing question mark instead of start up.

Update the driver on your *Hard Drive* with Drive Setup 1.6.1, which you can download, or version 1.7 which comes with the new B&W G3s. Make sure the Macintosh HD is selected in the Startup Disk Control Panel and run Norton Disk Doctor 4.0.3.

One, in particular, may prove a boon to eye glass wearers in general, and almost indispensable to the bi- or tri-focal set. It is not necessary to be a software engineer to increase or decrease the font size displays of the text in your browser. In Netscape Communicator 4.5 (includes Netscape Navigator), use Shift-*Command-*] to increase the font size or *Shift-Command-*[ to decrease the size of the font. Repeat the operation until the size is satisfactory. Of course, there are limits.

I have also found that this technique does not work at all sites. It does not seem to alter the font size on graphic home pages, but it does enlarge font size at links that contain nongraphic fonts. When the technique does work, it is instantaneous and does not cause the page to reload - at least on my G3. Your experience, if you try this, may be different.

For our newer surfers in the Internet and Beginner's SIGs. *Dogpile* may be just what you would like. This is a simple and efficient way to search all of the other search engines as well as newsgroups by merely typing your search criteria once. I have not the space to define each of the terms used here, but it may make for interesting Q&A at a SIG meeting or at the general meeting.
