July's Meeting

Bob LeVitus, author of over two dozen Mac books, contributor to several publications and newly appointed columnist for MacCentral. com, was guest speaker at our July meeting.

He spoke very entertainingly and positively about the new iMac which will enter the marketplace on August 15 (at 12 A.M!) Listing for \$1299 and reputed to be benchmarked faster than any Wintel 400Mhz PC, he predicts it to be the product that will bring Apple back into the competitive market. Also in iMac's favor is its innovative industrial design. On the down side, Bob lamented the short 90-day warranty that Apple has given this exciting new addition to their line.

Bob also discussed the complaint that outside of the desktop publishing area, Macs have a limited software selection – a major marketing limitation. In answer to this, he noted that many program packages have both Mac and PC capability - a fact not made clear in Apple's current ad campaigns. He hopes that vendors will someday display these versatile programs in a specially marked "cross platform" shelf area.



<CRASH> HEY ... I DON'T FEEL

I HAVE A HEADACHE.

SO WELL. DO I FEEL FEVERISH?

Manager. No problem - I would use Apple's Extension Manager that ships with OS 8, and it's free.

Big Problem - the product, to put it politely, is inadequate. Enter Conflict Catcher to the rescue. As its name implies, Conflict Catcher excels in identifying and isolating the offending startup item that is causing a system conflict. Conflict testing is automatic. Just click on the Conflict Test button, follow the onscreen

prompts, and with a little patience the system problem will be identified. Conflict Catcher can also display the date a startup item was installed or changed. This is very useful in identifying conflicts.

Conflict Catcher does much more than identify startup conflicts. When new software is installed, installers may put duplicate (oftenolder versions) of startup items into your control panel or extension folders. Conflict Catcher will

Technical Corner

▶ I have a PowerMac 8500 with a Agfa StudioScan IIsi flatbed scanner. I can't get the transparent media choice to be highlighted so I can scan some 4x5 chromes.

You need a Transparent Media Adaptor (TMA) replacement lid. The Software is capable of supporting scanners that do and those that do not have the TMA. Your software senses that you don't have the TMA hardware, so that choice is dimmed. The TMA is shipped separately since it is an option. You would remove the standard scanner lid, place the new TMA on top, screw down its hinge and connect its short cable to the small connect on the back of the base scanner.

I tried to load Macintosh Runtime for Java (MRJ) into my Netscape Communicator. After downloading MRJ, you have to mount the Disk Copy Image, run the installer to actually install it, then in Communicator, use the Java pop-up in Preferences to use the Apple MRJ for your Java virtual machine.

• Every so often my computer pauses and I hear all my hard drives being accessed. Sounds like you have the AutoStart 9805 worm. It corrupts files ending in .dat, .cod, csa, and .data on PowerPC based system via the AutoPlay feature of Quicktime 2.5 or greater. To confirm, use Find File to search for the invisible "DB" file(s) and in the System folder's Extensions folder "Desktop Print Spooler." Don't confuse this with the visible "Desktop Printer Spooler" and the invisible "Desktop" DB". Hold down the option key while clicking on the name popup to see four new choices including visibility. You should have one "Desktop DB" file for every partition or volume over 2MB (Floppies don't have them) Use



detect this and the next time you start up, you will be given the option of trashing the enabled or disabled duplicate item.

Conflict Catcher maintains a reference library of over 2100 files and URL links to the vendor of the startup item in your system. Click on the URL, and your browser will automatically be launched taking you to the vendors web site. The reference library also includes the vendor's software update address and e-mail address.



Have you ever wondered what that icon on the bottom of the screen is as your computer starts up? Conflict Catcher provides an option to display the name at startup. Conflict Catcher can also describe the function of most of the startup items in your system.

Conflict Catcher is excellent at startup item management. Items can be designated to load or not at startup. Startup sets can be created. Group links can also be created and displayed

in a separate window.

Further adventures of the Autostart Worm virus: An obvious result of

these infections is that when removed. they always leave a "hole" in the boot blocks of the Mac media on which they reside. As a result. any Autostart removal should always be followed up with a disk repair run to reconstruct the volume's structure. Norton Disk Doctor, Tech Tool Pro or Apple's Disk First Aid should all suffice for this purpose. Otherwise, you may be faced with a flashing question mark the next time





Beware of a false **Disinfectant 3.8:** A reader downloaded a file called Disinfectant 3.8 from Hotline Servers. There is no legitimate Disinfectant 3.8. The file is apparently a Troian Horse. After he launched it, a file called 10KFUN appeared in his Apple menu and other odd files and symptoms began to occur. Be warned.

NAV 5.0.1 with July virus defs or Virex 5.8.1 with July update to find and remove the files. If you can't afford either commercial solution, try the freeware WormScanner 2.1.1. It's only good port 1 and the laser on 2 when configuring for variants of the Autostart 9805 Worm so it's only a partial solution. You can manually get rid of the files with the shareware *DiskTools* or the commercial DiskTop if you can make them visible with *ResEdit* . Delete them with *Extensions* Off in the Finder. Turn off AutoPlay in the Quicktime Settings control panel to make sure you don't get re-infected this way. By the way, Disinfectant won't help and it will never be

updated. [See sidebar at below left for latest.] • Regarding OS X and the Power mac 9600: Even with a G3 upgrade card it still won't work?

That's right. Anything without an original G3 on the motherboard will not run Mac OS X. That leaves the 233, 266 and 300MHz desktop and mini-tower Power Mac G3s, the old and new G3 PowerBooks, the All-in-One Power Mac G3 for the education market and the forthcoming iMac are the only models up to now that will run OS X. Anything else is a dead end computer. That means anything older than 10 months old without that G3 processor natively on board won't be supported. It's because of device drivers like SCSI, video and network drivers. Maybe Connectix will release something akin to the old Mode32 for the Mac II, IIx, IIcx and SE/30 that allowed them to run in 32 bit clean mode despite their ROMs. I kind of doubt it though.

▶ How does *NAV 5.0.x* differ, besides the name from SAM 4.5.x?

I'd say first is HFS+ or MacOS Extended format support. Second is improvements over SAM, like support for unidentified macro virii, SAM could only repair whatever was in it's database. *NAV* has more PowerPC code so it's faster, comes on a bootable CD-ROM for emergency repairs. You can still customize its protection level like SAM could. It does require System 7.5 on a Quadra as a minimum and of course they recommend you update if you are using SAM. There is a \$40 rebate for upgraders.

▶ I updated to version 5 of *PortDoubler's* software, but I still have problems.

More Technical Corner file before installing the 5.0 release. Also I've found that port 1 and port 2 are treated differently, so if you have the common situation of a laser printer and a color inkjet, put the inkjet on

vour cables and settings. ▶ I have a Global Village modem. I want to leave it on and my answering machine on. I want to get faxes as well as have the answering machine work right. As it stands now, they fight it out and callers get an earful of noise.

The silent answer function on some modems is supposed to allow this if the answering machine can be set to not pick up on the first ring. (Kill the toss saver function.) I don't know anybody to actually get it to work. A \$60 "Com. Box" which can route calls to different devices, possibly with a distinctive ring service from the phone company should work well. Radio Shack has a cheap one (Cat #43-1244).

• How important is it to turn off your computer before plugging in or unplugging a serial cable? I switch connections between my printer and an external modem to my printer port only because the modem port is blocked and I haven't pulled my internal modem.

It's a crap shoot, You stand a chance of a spark frving your motherboard which would be very expensive to replace. You could go a year before this happens. If you don't want to open your case to remove the cap from the modem port and yank the slow internal modem, you could try a serial A/B switch to connect the modem and printer, but then you still could not print and be online at the same time, but at least you wouldn't have to shut down between switching, which I guess your not doing anyway. APS Technologies (1-800-925-4922) sells an good serial A/B switch with a simple push button. Bob LeVitus adds that he doesn't switch cables while the computer is on with his own Mac.



For those who want their Drive to be positioned in a different position on the screen: This is easy because Drive position is both scriptable and recordable. That means that you just launch Script Edit, press Record, move the Drive to the desired location, stop, and Save as an Application in the Startup Folder. Your Drive(s) will be positioned where you want them on launch. (If you rename the Drives, you must do this again or hand edit the name of the drive in the script.) -John Christie

User Group News

As you read this article MACWORLD NY is history and the iMac is the present (hopefully) shot in the arm the Mac platform needs for its future. This year's EXPO had fewer vendors, and booth size was significantly smaller. Also, there were fewer attendees visting the expo. To me, the show did not have the excitement of previous EXPOs. Much of this can be attributed to the shrinkage of the Mac market. Expo is Boston-bound for 1999

Next summer Macworld expo will be held Aug. 4 to 6 at Boston's World Trade Center/Seaport Hotel Complex. The Seaport Hotel will provide an additional 30,000 square feet of exhibit space, and eliminate the need for shuttle buses between the WTC and the Bayside Exposition Center which will not be used. The EXPO management said the Boston '99 show will maintain the expanded focus on "creative professionals established at the New York show while capitalizing on the EXPO's appeal to the consumer market."

Why move the show back to Boston? 1. In 1997 Macworld Boston had 48,000 attendees (of which 40% were consumers) 1998 MACWORLD NY had an estimated 34,200 attendess (of which 20% were consumers) 2. The cost to vendors doing a show in NY can be up to 50% more than a show in Boston.

According to an on-site survey of MACWORLD EXPO attendees, more than 96% came to the show to see the new products; 87% to keep up-to-date on industry trends; and 68% to compare products with current vendors.

The future holds incredible opportunity for the Mac market, The strength of the core Mac market and the hot Mac-related new media markets set the stage for MACWORLD EXPO '99 in Boston.
